Mr. Dargis thanked the Board and Committee for a great opportunity and looks forward to continuing the Black Gold tradition of success for all students.


### ELECTORAL WARD REVIEW


The Board directed administration to engage a consultant to facilitate a Black Gold Electoral Ward Review.

# ENHANCED PROFESSIONAL DEVELOPMENT PROGRAM (EPDP) PILOT- 2019-2020

Terri Reid, Learning Services Coordinator, and Cindy McRae, teacher at École Secondaire Beaumont Composite High School, attended the meeting to provide information on the Enhanced Professional Development Program (EPDP) Pilot.

Ms. Reid and Ms. McRae stated that the joint ATA/Black Gold Committee for the EPDP Pilot would like to extend this program for the 2019-2020 school year. Based on the feedback from members, some modifications to the original program have been incorporated to make it more equitable for all professional staff. As this is a Collective Agreement item, approval is required from the ATA Local and the BGRD Board of Education. The EPDP with the amendments was approved by the ATA Local at their last meeting. Trustees are supportive of professional development for teachers.

The Board extended the Enhanced Professional Development Program (EPDP) Pilot as amended by the joint committee for the 2019-2020 school year.



### STUDENT FEES

Associate Superintendent Andres presented the proposed School and Transportation Fees Schedule for 2019-2020. The approved fees will be posted on the individual school websites. Administration has proposed an adjustment/change in the following fees. The Board approved the recommendation from Administration for the proposed 2019-2020 Student Fees for the year ended August 31, 2020.

**Division Technology Fees** 

Grades 1-3 – payment of \$10.00 Grades 4-12 – payment of \$20.00

**Division Tuition Fees** 

(Day Extension Fees - Students 20 yrs+)

1 credit course - increase to \$125.00

3 credit course - increase to \$375.00

5 credit course – increase to \$625.00

Pre-K Program – Community Children – remain at \$800.00 Foreign Student or Out of Province – remain at \$12,000.00

**Transportation Fees** 

Bus Fee for Student Ineligible for Funding – increase to \$330.00 Bus Fee for School/Program of Choice – increase to \$330.00 Replacement Bus Pass – increase to \$11.00

Ineligible/School of Choice Students - Family Maximum - \$330.00/student or \$785.00/family



Increase of \$5.00/hour for gym rentals for all groups

#### BOARD PLANNING SESSION



Trustees and Senior Administration attended the Board Planning Session on May 9 and 10, 2019 at the Coast Nisku Inn & Conference Centre. The two Principals that attended were Jennifer O'Brien from

École Beau Meadow School and Jennifer El-Khatib from École Bellevue School. The Leadership Team from Division Office was also in attendance. Trustees thanked Administration for the preparation of the session and the information provided during the two days. Trustees also commented on the positive atmosphere at the session.

# APPOINTMENT OF AUDITORS

Associate Superintendent Andres stated that every five years the Division sends out a Request for Proposal (RFP) for our auditing services. The Finance Department has reviewed the proposals with set guidelines and criteria.



The Board accepted the recommendation from Administration to award the contract for auditing services to MNP LLP for the next five years, commencing the fiscal year ending August 31, 2019.

## APPOINTMENT OF Banking Services

Associate Superintendent Andres stated that Scotiabal every five years the Division sends out a Request for Proposal (RFP) for banking services. The Finance Department has reviewed the proposals with set guidelines and criteria.

The Board accepted the recommendation from Administration to award the contract for banking services to Scotiabank for the next five years commencing June 23, 2019.



# EXTENSION OF EXISTING BANK ACCOUNTS - TD BANK

Scotiabank\* Associate Superintendent Andres stated that our current banking agreement with Toronto-Dominion Bank expires on June 22, 2019. In order to facilitate the transition to an alternate banking services provider, the Finance Department recommends retaining the main



bank account and the U.S. bank account with Toronto-Dominion Bank, Leduc for an additional 6 months, up to and including December 31, 2019. All other accounts including Deferred Salary Leave Bank Accounts and Scholarship Bank Accounts will be closed on June 22, 2019.

The Board accepted the recommendation from Administration to retain the existing main bank account and the U.S. bank account with Toronto-Dominion Bank for an additional 6 months to December 31, 2019.
