



NOTICE TO EMPLOYER

AND EMPLOYEES

This letter confirms that the Board has initiated an application under section 12(4) of the *Labour Relations Code* to ensure the bargaining agency for teachers of each employer under the *Public Education Collective Bargaining Act, SA 2015, cP-36.5 ("PECBA")* is reflected in a Board certificate. This is to align the certificates pursuant to the statutorily deemed bargaining agency established under section 7 of *PECBA* and that each contains the correct employer name in accordance with Ministerial Order 34/2019. This process will also result in the revocation of various current certificates in the name of employers who have over time been consolidated into existing employers.

The Board proposes to revoke the existing certificates and issue new certificates as set out below.
