### CALENDAR UPDATE



Superintendent/CEO Romanchuk stated that they have distributed a survey for the 2021-2022 School Year Calendar, and are asking for feedback from Schools (staff) and

School Councils. The survey outlines four questions looking at the calendar and balance, staggered entry, possibility of having a fall break, Christmas break – when to start the break, Spring break – when to have the break occur, continue the same time or change? The survey has also been distributed to Division Office staff for feedback. Administration will bring back the information in December.

### NEW HUMBLE RINK LEASE

The Board directed Administration to pursue entering into a contract with the New Humble Community Group to maintain and use the skating rink at the New Humble Centre School.

#### 2021-2022 CAPITAL MAINTENANCE & RENEWAL PROJECT PRIORITIES

Associate Superintendent Volkman provided a summary of the 2021-2022 Capital Maintenance and Renewal Project Priorities. In late September, Boards were asked to identify priority Capital Maintenance and Renewal projects for the upcoming budget year. BGSD submitted eleven projects for a total of \$3.73 million. Projects include exterior envelope replacement, roofing, upgrading windows, replacing generators, and foundation repairs.



# TRANSPORTATION - BUS CONTRACTORS

Associate Superintendent Volkman received a request from the Bus Contractors' Association to support the additional expenses they are incurring due to new requirements related to COVID. Administration recommended providing the following support totaling \$158,000 to Bus Contractors for the 2020-2021 school year in relation to increased costs incurred due to COVID-19 requirements:

- Cleaning supplies for sanitizing buses total of \$28,900
- Additional time for drivers to clean the bus each day total of \$103,500
- Additional time spent creating and updating seating plans total of \$9,400
- Hold harmless rural contractors rates for routes where the weighted count significantly decreased due to the number of students accessing Distance Learning in their area – total of \$16,200

The Board approved the additional costs as presented to support the bus contractors for the 2020-2021 school year.

## INSURANCE UPDATE

Laurel Kvarnberg, Director of Finance, provided an update on the new insurance plan from Alberta Risk Managed Insurance Consortium (ARMIC). The focus of ARMIC is managing risk with the goal of achieving price stability over the coming years. ARMIC is currently piloting OpticRisk Management Software, which will be implemented across the Consortium. Each school will have one person trained in using the software and there will be a Super User in Division Office.



Based on recommendations from Marsh, ARMIC's insurance broker and the Risk Management & Claims Committee, the following motions were passed:

- Move that all ARMIC Boards follow the student travel guidelines of Alberta's Chief Medical Officer.
- Move that all ARMIC Boards purchase the Blanket Student Travel insurance policy for all future trips.

Ms. Kvarnberg also stated that risk management is key for Black Gold and all ARMIC Boards moving forward. There will be continued communication from ARMIC regarding 'best practices' in risk management in all areas, and it is imperative that these recommendations are implemented moving forward.

### WARBURG PLAYSCHOOL LEASE

Associate Superintendent Volkman announced that the Division has signed a lease agreement with the Warburg Playschool Society to operate a preschool class out of a classroom in Warburg School. The lease includes requirements for a minimum amount of liability insurance that must be carried by the Society and a requirement to adhere to Black Gold School Division's school re-entry plan.
