

COVID-19 MEASURES

Superintendent/CEO Romanchuk explained that the Government of Alberta (GoA) moved into Step 3 of lifting public health measures related to the COVID-19 pandemic on June 14, 2022. BGSD has and will continue to follow public health measures and, following the decision of the GoA, BGSD has rescinded the 2021-2022 Easing Restrictions: Moving from Pandemic to Endemic Plan posted online on February 28, 2022. Staff and students have been notified.

APPROVED TRAVEL



Associate Superintendent Dargis referenced Administrative Procedure 260 Appendix A – Student Excursions Approving Authorities and explained that due to the COVID-19 pandemic, a moratorium on domestic and international student travel has been in place since June 2020. With pandemic restrictions associated with travel beginning to ease, the opportunities for schools to plan domestic and international student excursions are increasing. With the length of time required for submitting requests to travel outside of Alberta and Canada, a Board decision

to permit requests for domestic or international travel would need to occur immediately if excursions are to resume for the 2022-23 school year.

The Board approved the opportunity for schools to resume the planning of and application for Board approved domestic and international student travel.

DIVISION OFFICE ADMINISTRATIVE/PROFESSIONAL SUPPORT/FACILITIES & OPERATIONS STAFF

The Board directed Administration to provide a 1.25% salary increase to Division Office Administrative Staff, Professional Support Staff and Facilities & Operations Staff effective September 1, 2022.

Trustee Steed suggested that a Council of School Councils occur in the fall, where a representative from the Alberta School Councils Association (ASCA) could host some workshops to help the new and returning School Council members increase capacity. Trustees supported looking into arranging a fall Council of School Councils.
